

# GUIDELINES ON APPLICATION FOR DOMESTIC SHIPPING LICENSE

MINISTRY OF TRANSPORT MALAYSIA

(Last updated 29 September 2023)

#### **1. INTRODUCTION**

# **Domestic Shipping**

Definition of domestic shipping under Section 65A of the Merchant Shipping Ordinance 1952 [Ordinance No.70/1952] ("MSO 1952") refers to the usage of vessels for the following purposes:

- (a) to provide services, other than fishing, in the Federation waters or the Exclusive Economic Zone; or
- (b) for the shipment of goods or the carriage of passengers:
  - i. from any port or place in Malaysia to another port or place in Malaysia; atau
  - ii. from any port or place in Malaysia to any place in the Exclusive Economic Zone or vice versa.

# **Domestic Shipping License**

Section 65L of OPS 1952 provides that all vessels engaged in domestic shipping services must have a Domestic Shipping License (DSL). The failure of any owner, charterer, master or agent of a ship to possess a valid license is an offense and if convicted of such offense is liable to a fine not exceeding RM10,000 or to imprisonment not exceeding one year or to both.

#### Exemption from Section 65L MSO 1952

Subsection 65L (3) MSO 1952 provide exemption from Section 65L to the following Malaysian Registered Vessels:

- a) net weight under 15 tonnes;
- b) licensed under Section 475 MSO 1952 (boat license);
- c) licensed under MSO 1960 (Sabah) and (Sarawak); ); and
- d) owned/leased by Malaysian Government, State Government or Port Authority.

# **Cabotage Policy**

Section 65KA MSO 1952 restricts domestic shipping to Malaysian Registered Vessels only. The use of Foreign Registered Vessels can only be considered if the Malaysian Registered Vessel is unable to meet the demands of certain sectors subject to the terms and conditions set by the Minister of Transport

# 2. SOURCE OF POWER

- (a) Merchant Shipping Ordinance 1952 [Ordinance No.70/1952]; and
- (b) Domestic Shipping Licensing Board Regulations 1981 [P.U(A) 27/1981].

# 3. TERMS OF APPLICATION

- (a) DSL Application shall be made to Domestic Shipping License Board (LPPDN) by:-
  - A company incorporated under the Companies Act 2016 [Akta 777] with at least 51% of shareholding and composition of company director are held by Malaysian citizen;
  - ii. **Individuals** with Malaysian citizenship (for Malaysian Registered Vessel owned by individual only).
- (b) DSL application must be submitted together with the supporting documents specified in paragraph 4.

v. Letter of Appointment for Agent / Ship Manager (for MISR vessel and Foreign Registered Vessel)

(d) Subject to Regulation 6 P.U (A) 27/1981, LPPDN may apply for any additional information or documents as deemed necessary by LPPDN for the purpose of determining the suitability of the applicant for a license. If any additional information or documents are not submitted, the DSL application shall be deemed to have been withdrawn and cannot be continued but without prejudice to a new application made to the LPPDN.

# 5. APPLICATION PROCEDURE

- (a) Application can be made through **Domestic Shipping License System (eDSL System)** at the website <u>www.edsl.mot.gov.my</u> using the prescribed Form;
- (b) All supporting documents as stated in paragraph 4 must be uploaded to eDSL System.
- (c) Application must be submitted before the project starts (for new applications) or at the latest 2 months before the existing license expires (for renewal applications)

#### 6. DURATION AND TYPE OF LICENSE

# 7. FI CHARGES

#### 8. APPROVAL PROCESS

#### (a) Malaysian Registered Vessel

License application results for Malaysian Registered Vessel will be given not later than three **(3) working days** from the date of receipt of complete application.

#### (b) Foreign Registered Vessel


#### i. Without Counter Offer

License application results for Foreign Registered Vessel that was not subjected to counter proposal from local ship owners will be given not later than **three (3) working days** from the date of receipt of complete application.

#### ii. With Counter Proposal

License application for Foreign Registered Vessel that was subjected to counter proposal from local ship owners will have to go through negotiation/and mediation process before any decision can be made. License application results will be given not later than **10 working days** from the date of receipt of complete application.

# 9. PAYMENT

- (a) Payment can be made through online transacation using FPX or credit card;
- (b) Payment must be made within 14 days. License approval will expired automatically if no payments were received within that time;
- (c) Approved transaction cannot be cancelled.

# **10. REVOCATION**

- License must be printed and displayed on board the licensed vessel for inspection purpose;
- (b) License is not transferable;
- (c) License may be revoked if:
  - i. there is a violation of the terms and conditions;
  - ii. there is falsification of document/information during the application;

- iii. the vessel is not at the licensed location;
- iv. the vessel does not implement the project as licensed; or
- v. valid license is not kept/displayed in its proper place.

#### **11. TERMS AND CONDITIONS**

- (a) All term and condition for license application can be referred at eDSL System User Guide page at <u>www.edsl.mot.gov.my.</u>
- (b) Any changes, addition or cancellation of current terms and conditions for license application are subjected to provisions of the law in force and the decision of LPPDN from time to time.
